Conditions of Competition

1. Entrance fees should be paid at time of entry.
2. The competition shall be played in accordance with the Rules of Golf, as adopted by the Royal and Ancient Club of St. Andrews, Scotland, together with such local rules as are in force at Goonawarra. If a dispute arises over any point, it shall be decided by the Match Committee, whose decision shall be final, provided, however that any player may request the Secretary of her Club to ask the Executive Committee of Women's Golf Victoria, for interpretation of any rule, or the procedure in any case.
3. In this event, competitors will be drawn in groups by the Match Committee or such person as they may authorise. Any competitor who is not at the assigned tee when called upon at the published starting time may be rescheduled to another group only if possible.
4. The Match Committee will make all arrangements and will have full power to make any variation in the conditions of the program, should they deem it desirable.
5. The Match Committee, or such person as the Match Committee may authorise, may in the event of bad weather, or for any other reason, either shorten the contest, or fix another day.
6. In the event of a tie, the result will be decided on a count back as per W.G.V. Rules.
7. The event is open to all players from Clubs registered with Women's Golf Victoria.
8. The attention of all entrants is drawn to the necessity of complete accuracy in her entry form. Any entrant who misrepresents herself is liable to disqualification.
9. The Match Committee shall have the power to limit the number of entries which will be received in any event, and to alter the time fixed for starting any event as indicated in this program.
